5.1 Monthly Financial Update

Rick Leibowitz reported to the Board that everything budget related is right on track, as expected, and there is nothing key to comment on. He shared that he attended an OCCA meeting regarding the state budget picture and funding to be expected from the state, as well as a PERS workshop which explained the new PERS rates amongst other related topics. The Board had asked Rick a couple of questions that he will be researching and giving updates on at a future board meeting.

5.2 Enrollment Update

Eric Studebaker, Chief Student Services Officer, hit the quick points regarding enrollment. As enrollment is not locked, due to the severe weather, Student Services extended the registration period and ability to drop courses. He added that it has been an exceptional winter, which has been frustrating for students with the FTE down 7.5% compared to winter term of last year. However, one new Oregon Promise student has registered for this winter term. Eric will present more concrete enrollment numbers after registration is closed for the term.

5.3 Operations Update

President Frank Toda elaborated on one of Eric's previous points mentioning that this is the worst winter weather the Columbia River Gorge has seen since 1979. The snow and ice impact has been heavy which in turn created an all-around impact on the college and its operations. Dr. Toda also shared that the college has incorporated the use of GoogleDocs for sharing intercollege documents, which can also be reviewed/edited by any of the peers that the document has been shared with, with certain features. Following that information he went over the updated revisions to the college Strategic Work Plan for 2016-2019.
