### ECEFS Exit Requirements:

Students must meet practicum competencies for the certificate and the degree. Students may retake classes in order to meet the grade requirement with the exception of the following: 1) ECE Practicum 1 (ECE 130B, ECE 134) 2) ECE Practicum 2 (ECE 130C, ECE 135) 3) ECE Advanced Practicum 1 (ECE 260A, ECE 264)\* 4) ECE Advanced Practicum 2 (ECE 260B, ECE 265)\* These classes may be re-enrolled in only once after a student receives a grade of less than "C." Department approval is required for any student desiring to attempt any ECE course for the third time. Credits required depend on individual student competency as evaluated by ECEFS instructors.

### Practicum Requirements:

To be considered for practicum, students must:

- 1) Be enrolled in the Oregon Child Care Division, Central Background Registry;
- 2) Submit verification of measles immunization;
- 3) Submit verification of TB Skin Test;
- 4) Complete a Food Handler's Certificate; *and*
- 5) Submit a copy of your current Infant/Child First Aid/CPR Card

Costs associated with required practicum documentation are the sole responsibility of the student.
