## Before the term begins:

- FIRST obtain a signature from your host school. Host school will mail or fax this form to CGCC along with a copy of your registration. It's the <u>student's</u> responsibility to check that this has been completed and submitted to CGCC. This form must be submitted by the first week of each term.
- 2. Pay your tuition and fees at your host school or make payment arrangements according to their terms and conditions.

## After the term is over and grades have posted:

 Submit an <u>official</u> transcript from the host school to CGCC by the first Friday of the following term so that credits can be transferred toward your CGCC degree or certificate. Satisfactory Academic Progress eligibility is determined once an official transcript is received. Future funding may be postponed/canceled until this has been completed. Note: Loan borrowers must submit a Direct Loan Revision form to reinstate any canceled loans.

## Criteria:

- 1. Students can only receive financial aid at one school. You must apply each term of dual enrollment.
- 2. Courses that are taken at the host institution must apply toward your degree or certificate at CGCC.
- 3. Courses that are upper division (300 or higher level) at the host school will not be funded by CGCC.
