*** Method of Assessment 3. What methods will be used to assess individual student understanding of each of these outcomes? (Please be specific.) Outcome #1: Method to assess student understanding**

#1 Students will write 5 annotation essays over the course of the term. Annotation assignments ask that students analyze a primary text using concepts discussed in assigned critical texts and discussion from scholars in the field.

*** Outcome #2: Method to assess student understanding**

#2 Students will produce a final project that demonstrates their ability to analyze texts and lectures studied over the course of the term. This project will synthesize course content related to narrative folk genres with a focus on 1-3 myths and/or folktales studied in class. Project asks students to connect their chosen primary texts to critical works presented in class and to motifs and themes still relevant today.

*** Outcome #3: Method to assess student understanding**

#5 Students will participate in weekly discussions to analyze mythology and folklore texts read through the term. Initial discussion posts must include evidence from the primary text, discussion of themes and motifs, and make use of literary terms learned in class.
