Procedural issues and changes for Curriculum Committee and Curriculum Office

- 1. Add to the "Text & Materials" section in the CCOGs a header clarifying that listed texts and materials are suggested rather than required. Required texts and materials will be clearly identified. (9.24.20, 10.22.20)
- 2. Add notation in CCOG development template requiring the content section to be built in outline format or bullets under each outcome. (9.24.20)
- 3. Departments should develop a separate CCOG for courses even those often taught in combination, i.e. a combination of two levels of math; however, when teaching these courses in combination, an additional CCOG is required to reflect the accelerated nature of the combo, the desire to move students through two levels in one term. The combo course would represent a third version of the courses. (9.24.20)
- 4. Add "Old Business" to the CC agenda. (10.8.20)

- 5. To reflect actual current use, the Consent Agenda was revised to be a Modified Degree/Certificate Revision form which can be used to update/revise degrees/certificates for the revisions that don't require a full submission: course titles, course numbers, degree/certificate title change, addition/deletion of degree/certificate electives. The Consent Agenda will no longer be an official form. Items may be placed on a Consent Agenda if appropriate without there being a specific form. (2.11.21, 3.4.21)
- 6. Use of Roberts Rules removed from CC Charter. Recording of CC procedural rules that had been agreed upon over the years to replace Roberts Rules. (3.18.21, 4.8.21, 5.6.21, 6.3.21)
- 7. Add to Procedural Rules that: "Officers are elected from among the voting faculty." Previously an unofficial understanding that was adopted officially here. (6.3.21)
- 8. Committee meeting schedule for the 2021-22 academic year. September Orientation and May Retreat are limited to submissions for new degrees or certificates. Otherwise these meetings are reserved for committee review of curricular policy and issues. (6.12.20)
